1. Foundation Member.

Foundation members represent the highest subscription class and will have temporary control of the organization during the establishment phase. They will be integral to the initial success of the committee and are vital to the quality of leadership, the growth of a strong, dynamic and diverse membership base, and the development of sustainable projects of long term value to the community.

Available to:

Individuals and businesses with an interest in The Bellarine.

Membership Benefits:

- The right to submit your own strategic Project for endorsement by the Board as an Endorsed Strategic Project (ESP), which will be driven by the Executive Director and achieved with a Taskforce
- Direct access to Committee for Bellarine Executive Officer.
- Eligible to be elected to any one of up to 9 board positions including one of up to 4 board positions reserved for Executive members
- Opportunity to chair a Taskforce
- Two (2) member representatives per subscription with full voting rights
- Private briefing twice a year with the Executive Director
- Invitation to attend at least 2 Boardroom briefings
- Both representatives plus one guest able to attend (free of further charge) quarterly

3. Associate Member.

Associate members are likely to be individuals with small business located on The Bellarine but need not be. Outside of the Board, they do not have voting rights.

Generally to individuals and businesses with an interest in The Bellarine. The Board will seek annual Expressions of Interest. Membership is restricted to one year terms of membership but may be extended.

- Invitation to attend periodic Board room briefings
- One place (free of further charge) to attend each quarterly Round Table Dinner (4 times per year)
- Full voting rights

4. Community Member.

Community members provide broad based representation and opinion on the Committee. Limited to 3 positions, the Board will seek annual Expressions of Interest. Membership is restricted to one year terms of membership but may be extended and the annual subscription is nil.

- Not-for-profit organisations associated with The Bellarine. Expressions of interest will be sought.
